**Subject: Seasonal Flu Shot Policy - 2009**

In preparation for the upcoming flu season, we wanted to provide you with our flu shot policy for 2009. Before providing the policy, it is important to note that the vaccines are expected to be available beginning October 1, 2009.

Pharmacy Flu Shot

Similar to last year, members may obtain a flu shot at no charge from Albertsons or Safeway pharmacies. Albertson's pharmacies also include Sav-On and SuperValu, and Safeway pharmacies also include Vons.

In order to receive a flu shot at no charge at one of these participating pharmacies, the member will need to present their Health Net ID card at the time of service, which will need to be during the hours and at locations administering the flu shots.

Physician Office Flu Shot

Members may also receive a flu shot from their physician. At the physician's office, a copayment or deductible/coinsurance may apply, dependent upon the plan benefits.

On-Site Clinic

If you have 50 or more employees and dependents who would be receiving the flu shot at one location, at one time, you have the additional option of setting up a flu shot clinic. To set up an on-site clinic (which will also be offered through Albertsons and affiliates, and Safeway and affiliates) you will need to contact your vendor of choice, and meet the minimum number flu shot requirement per location. Advance notice of 4 to 6 weeks is highly recommended, to ensure you receive the time slot you prefer.

The following vendors offer on-site clinics and will bill Health Net directly, alleviating additional paperwork that would otherwise be required:
